NYS Grants Reform Project Launches Web-Based Grants Management System

A web-based grants management system, Grants Gateway, will be launched at stages this year. This site is intended to be a one-stop location that will improve the way grants are administered by the State. The system will be rolled out in phases that include:

- Opportunity Portal (Spring 2013) A simple way to search for grant opportunities and register to receive notifications.
- ◆ Document Vault (Spring 2013) A secure online document repository for the grantees to store and share commonly requested documents.
- ◆ Online Contracts (Fall 2013) Ability for grantees to apply for, develop and execute contracts online.
- Online Claims (Fall 2013) Ability to submit a request for payment, supporting documentation and track status online.

Municipalities are beginning to see letters from the Division of Budget with additional information on the process along with a registration form that will be used to input your organization's information into the system and authorize your grant administrators to use the system. The form, asks for key information that is required in completing most grant applications, such as your Federal ID, SFS Vendor ID and DUNS Number.

If you do not know your NYS Vendor ID, you may contact the Statewide Financial System Help Desk at HelpDesk@sfs.ny.gov or call toll free at (855) 8363 and be ready to provide your Federal ID number. DUNS numbers can be searched online at https://www.dandb.com by clicking on 'D & B DUNS number' at the upper right and then selecting 'search for D & B DUNS 'from the drop down.

Training opportunities will be offered and organizations are asked to visit www.GrantsReform.ny.gov to stay up to date with the NYS Grants Reform effort. New Punkeyville State Forest Named



In celebration of Earth Day, Commission staffers Gerry Ritter and Katie Malinowski and Commissioners Ken Vigus and Arnie Talgo joined with officials from the NYS Department of Environmental Conservation, Tug Hill Tomorrow Land Trust, and the Town of Forestport to recognize Forestport Elementary school and students for participating in the Name The State Forest contest. The winning name, Punkeyville State Forest, was nominated by two students, Phoenix Swasey (5th grade) and Dylan Cabic (4th grade). The two winners, as well as the runner up, Joshuah Guernsey (5th grade), and the school were all presented plaques

with the name of the State Forest. The second place

submission was "Wildcat State Forest."

The 518-acre state forest located in the Town of Forestport, Oneida County was purchased late in 2012. It protects almost one mile of the Black River shoreline, expanding recreation and forest management opportunities on lands in the foothills area between the Tug Hill Plateau and the Adirondack Park.

"Punkeyville State Forest is a great name. It provides a strong historical link since Punkeyville was the early name of the settlement that is now called Forestport," Judy Drabicki, DEC Region 6 Director said.

Revised Flood Insurance Study and New Flood Insurance Rate Maps for Oswego County

The Federal Emergency Management Agency (FEMA) has recently completed a revised Flood Insurance Study and new Flood Insurance Rate Maps (FIRMs) for all Oswego County municipalities. Communities that wish to continue participating in the flood insurance program are required to adopt the new maps by revising their existing flood-plain management ordinances. NYSDEC has information on updated model ordinances at their website http://www.dec.ny.gov/lands/39341.html. The new models include new language that more closely meshes with the current NYS building code. Oswego County municipalities have until June 18th to adopt the new measures. FEMA recommends that communities contact William Nechamen, the National Flood Insurance Program state coordinator at (518) 402-8146 with questions about the process.

Participation in the National Flood Insurance Program is based on an agreement between local communities and the Federal Government that states if a community will adopt and enforce a floodplain management ordinance to reduce future flood risks to new construction in Special Flood Hazard Areas (100-year floodplain, or areas subject to a 1 percent or greater chance of flooding per year), the Federal Government will make flood insurance available within the community as a financial protection against flood losses. If communities do not participate in the National Flood Insurance Program then insurance companies cannot write policies for that community and federally regulated lending institutions are prohibited from issuing mortgages for properties within mapped Special Flood Hazard Areas as depicted on the Flood Insurance Rate Map.

Wilna Urges Federal Funding To Complete Cleanup Of Superfund Site

The Town of Wilna Board unanimously approved sending a letter to the U.S. Environmental Protection Agency (EPA) requesting the demolition of the crumbling and decayed industrial buildings and to remediate contaminated ground & water issues/concerns at the "Crown Cleaners of Watertown Superfund Site." The \$7.2 million multi-year remediation initiative was funded through the 2012 federal budget and did not carry over to the 2013 budget year.

The 9-acre industrial site was placed on the Superfund list by EPA in 1991, due to ground & water contamination from the former dry cleaning facility. Over the past 20-years, EPA has completed a series of ground & water contamination research, tests and studies. In 2012, town/village residents, local officials and interested parties were presented a Record of Decision (ROD) to identify the preferred recommendation in addressing issues/concerns on the site. In preparing to guide future development along the waterfront, the town also resolved property ownership issues in June 2012 by taking ownership of the property, to guide future development of the waterfront site as a recreation park. However, building demolition, ground & water remediation and clean-up efforts by EPA are still pending in 2013 and contingent upon accessing available funds.

The letter from Wilna to the EPA was also sent to federal and state legislative representatives to provide updated information in a coordinated effort to identify available funds to complete the clean-up effort of the Crown Cleaners site.

Jefferson County Planning Department Organizing Emerald Ash Borer Training May 8

The New York State Department of Conservation (DEC) will offer a 2-part training session on the Emerald Ash Borer on Wednesday, May 8 at 8:00 a.m. in the large conference room at Cornell Cooperative Extension of Jefferson County, 203 North Hamilton Street in Watertown.

The "first detector" portion of the training, from 8:00-9:00 a.m., is designed to increase EAB awareness among anyone who cuts or trims trees, helping them to better recognize and report signs of EAB. The planning portion of the training, from 9:15-10:00 a.m. is designed for anyone who has a role in creating preparedness plans to limit impacts from EAB, and will demonstrate the importance of being proactive in EAB planning.

This free event is being organized by the Jefferson County Planning Department at the request of the DEC, with assistance from Cornell Cooperative Extension of Jefferson County and the Tug Hill Commission. CaRDI Report Released for Upstate NY

Cornell's Community and Regional Development Institute have released its report "Upstate New York in Profile: Trends, Projections and Community & Economic Development Issues." The document can serve as a resource for decision-makers at multiple levels of government and community organizations, to help leaders and decision makers track trends over time, examine projections, and consider public opinion on a host of emerging policy issues in key development areas of upstate New York. The chart book integrates New York State-based survey data, census and other secondary data sources, and provides important links to more information on several key community development topics such as energy, food systems, economic development, schools, and health care.

Grants Available From Lowe's

Lowe's home improvement stores announced its 2013 Community Partners grant program. The program helps build better communities by providing monetary assistance to non-profit organizations and municipalities looking for support of high-need projects such as: building renovations/upgrades, grounds improvements, technology upgrades as well as safety improvements. Grants range from \$5,000 to \$100,000, with most projects falling between \$10,000 and \$25,000.

Applicants will be notified within approximately 90 days of the deadline.

Additionally the company also offers a **Small Grants Program (less than \$2,000)**. The small grants program is seeking smaller-scale assistance for non-educational focused projects. These grants range from \$100 to \$2,000. Small grant project requests must also fit within the Lowe's Charitable and Educational Foundation guidelines.
