Open Meetings Law Q & A

The NYS Department of State's Committee on Open Government has a web page full of questions and answers regarding Open Meetings Law. <http://www.dos.ny.gov/coog/QA-2-12.html>. When a record is scheduled to be the subject of discussion by a public body during an open meeting, the legislation requires the public body, with reasonable limitations, to make the record available to the public prior to the meeting. Optimally, the record will be made available online; if that cannot be done, the record can be made available in paper form in response to a request.

Community Involvement Plan for Herrings and Carthage

The U.S. Environmental Protection Agency (EPA) and its contractor Ecology and Environment, Inc. are creating a Community Involvement Plan (CIP) for the sites listed on the EPA's National Priorities List in the Villages of Herrings (known as Crown Cleaners) and Carthage (named by EPA as Black River PCBs). The CIP for each site will provide EPA with a framework for how the community would like to be informed on site activities and provide input throughout the site remediation process. The CIP will also describe the site history, scheduled activities, and how to contact EPA representatives. EPA will also establish a local information repository where the plan and project-related public documents will be made available for review. The CIP is meant to be a "living document," meaning that it will be modified as new information and issues develop while site cleanup activities are ongoing.

EPA usually has the Community Involvement Plan done before the project proposal is completed, but in the case of Crown Cleaners in Herrings, the CIP has not yet been finished. Remedial investigation work in Carthage is just beginning.

The Town and Village Courts play a vital role in the New York State Unified Court System. These courts have broad jurisdiction and they hear both civil and criminal matters. The Justice Court Assistance Program (JCAP) recently contacted town and village justices inviting them to apply for a 2012-13 JCAP Grant. The maximum JCAP grant is \$30,000 per court. The money can be used for a variety of purposes including office and security equipment, furniture, courtroom and court faculty improvements and renovations. Applications for JCAP grants may be submitted by the Justice Courts or by Towns and Villages on behalf of the court. Applications and accompanying paperwork should be submitted by **October 1, 2012**. The application itself must be submitted online, however, the following items must be submitted by mail as hard copies:

- Estimates
- Board resolutions
- Court's Annual Budget
- Signature Page

When you click on the online grant application, you must enter an Account Name – which is “court” and a Password – which is “jcap” (all lower case letters) to start the application. Parish Village Hears Presentations on PILOTs, Potential Buyer

Nearly 60 residents attended a special presentation at the Village of Parish board meeting last night, to learn about developments in the efforts to find an appropriate use for the vacant elementary school in the Village. Mayor Heagle opened the meeting, with the Village's consultant Peter Fairweather then reviewing the planning that has been done so far to keep this important community resource in use, add energy and vitality to the Village and Town, and to enhance the Town and Village tax base. Oswego County Industrial Development Agency head Michael Treadwell then explained their role and the potential use of a Payment in Lieu of Taxes agreement to help locate a manufacturing use at the site. Lastly, Mike Bovalino from Biospherix spoke to the group about the company's potential plans.

Mr. Bovalino explained that Biospherix is a locally owned company started in the early 80's in Redfield. It currently operates out of the former Blount Lumber building in Lacona. The company has grown in recent years to 52 employees and expects to continue to expand over the next few years. They have been looking at property in Oswego County to relocate into, as all of their employees are from either Oswego or Onondaga County. Biospherix makes clean rooms for research and hospital applications, and sells them worldwide.

Attendees asked many questions regarding property tax payments, sewer use rates, potential noise and traffic impacts from an industrial use on the site, etc. At the end of the meeting most people seemed to feel that this was a good opportunity for the Village and surrounding area, and should be pursued.

Third Annual Black River Trash Bash Plans Underway

The Tug Hill Commission, together with the Lewis County Soil and Water Conservation District, would like to draw your attention, once again, to the Black River and its important ecological and economical status in our region. Since the completion of the Black River Watershed Plan, our agencies have organized this cleanup event and is, again, asking for support from your community group to participate. The event raises the public's awareness of the state of our shorelines and generates important data that show trends in pollution.

The 2012 International Coastal Cleanup Day is September 15, however, you may hold your local Black River Trash Bash event in either the month of September or October. The Tug Hill Commission will assist you with your data reporting. Remember, you must be able to properly dispose of your trash bags and be willing to weigh your trash. **If you would like to host an event, please contact Jennifer Harvill at the Tug Hill Commission at 315-785-2392 or jennifer@tughill.org.** Responses would be appreciated by August 24th.

Since 1986, the Northeast Chapter of the American Littoral Society (ALS) has coordinated New York's participation in the annual September International Coastal Cleanup (ICC). This effort has the overarching sponsorship of the Ocean Conservancy in Washington, DC. The Cleanup is a worldwide event in which over 100 countries and almost all of our states participate. **Last year, worldwide, 6,368 volunteers removed 186,582 pounds of debris from 262 miles of shoreline.**

A thought to consider: Litter travels from hundreds of miles inland. A plastic sandwich bag blowing off a picnic table far inland washes down a storm drain, river, lake or stream, and winds up being eaten by a sea turtle. The problem is increasing with significant implications for wildlife, fishing, human health, tourism, water quality and marine ecosystems.
