## Work Continues on Camden Village Zoning Overhaul

The Camden Planning Board is nearing completion of an update to the village's zoning law. The law is being amended to better implement the land use and development policies laid out in Camden's 2014 comprehensive plan. Among the improvements are a reduction in the number of zoning districts, simplification of the sign provisions, updated parking requirements, and improved provisions for nonconforming uses and structures. The finished product will be reviewed by the Oneida County Planning Board and adopted by the village board.

## Town of Constantia Launches New Website

The town of Constantia has a new website! After over a decade and a half with its existing website design, North Shore Council of Governments circuit rider Paul Baxter redesigned the town website in consultation with town officials. This website also serves as the prototype for the redesign of other websites hosted and maintained by the North Shore Council of Governments and the Salmon Rivers Council of Governments.

The existing website was maintained by hand-coded HTML, the code behind the display and operation of web sites. In addition, it was much less granular in the levels of permission possible for website modification. The new website has WordPress as its underpinnings, making updates easier, for people to do without specialized knowledge of web code, and giving the website a more modern appearance.

# Workshops for Lingering Ash Detection Available

The Ecological Research Institute (ERI) is now scheduling training workshops for implementation of its Monitoring and Managing Ash (MaMA) program. For information on this innovative, comprehensive approach to ash conservation and Emerald Ash Borer (EAB) management, see ERI's website at [www.MonitoringAsh.org](http://www.MonitoringAsh.org). MaMA's innovations include adapting U.S. Forestry Service protocols for monitoring ash mortality and detecting lingering ash (EAB-resistant trees) to make them easily usable by land managers and citizen scientists. These trees offer the best hope for ash conservation and restoration (see [www.monitoringash.org/lingering-ash-info/](http://www.monitoringash.org/lingering-ash-info/)).

In this workshop, participants will learn, among other things, how to establish ash mortality monitoring plots that form part of the rapidly expanding **MaMA Monitoring Plot Network** extending through much of New York State and beyond, which is coordinated by ERI. ERI uses the data from this network, in close cooperation with the USFS, to determine when particular areas are ready to search for lingering ash. **Because of this network's use of scientifically rigorous protocols, attendance at an ERI MaMA training workshop is required for participation.** Similarly, this workshop is required for participation in MaMA's lingering ash reporting project, given the importance of finding trees that meet strict criteria.
