# **Olympic Byway Draft CMP**

Western Segment of the Olympic Byway

## **Existing Studies and Programs Component**

The existing studies and programs included in this report also extend to awarded grant applications to document local planning initiatives to enhance sustainable community development around the tourism industry by attracting visitors around natural, cultural, historic, recreational, and scenic resources. The list of plans, studies, reports and grant applications document local & regional efforts to maintain, protect, preserve, and enhance area resources to attract visitors through promotion & marketing campaigns into communities along the corridor. Recommendations identified in the resource list are supported by existing studies and are woven throughout the draft CMP document as likely partners/stakeholders advance specific initiatives.

Also identified in this segment of the report is a list of promotion & marketing brochures featuring information about specific attractions and resources.

The "Black River Corridor Economic Adjustment Strategy" (2001): (Copies available at JCJDC Office # (315) 782-5865 contact person: Mary Ann Hanley) – Undertaken by the Center for Community Studies at Jefferson Community College with grant funding from the US Economic Development Administration, Empire State Development Corporation, Jefferson County, NY and Senator James Wright, NYS Senate and administered by Jefferson County Job Development Corporation (JCJDC) for JCJDC, Development Authority of the North Country (DANC), Empire State Development Corporation (ESDC) and Jefferson County Planning Department.

A four-pronged approach, the project assesses economic development opportunities and provides guidelines and recommendations in communities along the Black River Corridor. As segments of the Black River Corridor traverse the Route 3 Corridor designated by the state as the Olympic Byway, the Task C Component: Commercial Opportunities Related to Tourism Initiatives in the Black River Corridor documents economic development opportunities based upon the tourism industry. The purpose of the study is to develop a plan to capitalize upon the natural and recreational resources of the Black River.

A segment of the Task C report is devoted to recommendations to enhance opportunities to attract visitors into local communities based upon product development of the river.

Also identified in the report are a list of regional and local entities/groups promoting and marketing river activities. Also identified in the report is an emphasis upon the

importance of organizing and coordinating events along the river to successfully promote the area as a destination for visitors. A list of regional and national strategies to promote events and activities is outlined in the report and opportunities to co-promote Class V River's in the Northeastern US and Southeastern Canada.

The strategy report emphasizes the importance of signage along the Black River and Downtown Watertown as a key element to attracting and retaining visitors and supports the 3 goals and objectives included in the CMP draft report. In addition, recommendations identified in the Task C Component of the Black River Corridor Economic Adjustment Strategy are incorporated into the "Recommendations" segment of the Corridor Resource List.

"Rt. 3 Black River Corridor Community Design Initiative" – (February 2002) – The Village of Black River and the Towns of Champion, Pamelia, LeRay, & Rutland formed the Rt. 3 Sewer Board through an Inter-Municipal Agreement (IMA) to build a sewer infrastructure. As part of the infrastructure project, the sewer board contracted with an Architectural Design Firm to develop a generic planning tool to assist local officials in designing their communities to guide future development.

Important to the preservation and protection of the rural landscape, the design initiative provides members of local planning, zoning, town and village boards with guidelines for sustainable development using principals of rural and urban design around landform, structural, vegetation, & circulation patterns.

Designing communities is a proactive approach to planning that can be replicated in other communities to assist in identifying and maintaining characteristics that make them unique to the byway and builds upon natural, cultural, historic, recreational, and scenic resources.
