Grant season is in full swing and many communities are wondering how they can take advantage of the many opportunities that are out there. The key to being successful in grant writing is having a well-developed project in advance of the grant deadline announcement. Putting together a project budget, generating community support, and researching all the details of your idea take time. Commission staff is available to help you through the process and to point you in the right direction. Black River Watershed Conference

Registrations begin Monday April 27th for the 2015 5th Annual Black River Watershed Conference. This year's conference will take place on June 3 at the Hayloft at Moonshine Farm, 6615 Buneo Rd., Port Leyden, NY 13343. The event is organized and hosted by the Tug Hill Commission, the Lewis and Jefferson County Soil and Water Conservation Districts and the NYS DEC Region 6. Sponsors include 5 Finger Lakes Lake Ontario Watershed Protection Alliance Counties (Jefferson, Lewis, Herkimer, Oneida and Hamilton) and the Beaver River Advisory Council. Sponsors help keep the conference affordable at just \$25 per person. This includes refreshments and lunch and the afternoon bus tour.

Registration on June 3rd begins at 8:00 am with speakers beginning at 8:20 am. Morning topics include Invasive Species, Green Infrastructure, Updates on Watershed Projects including an MS4 Update and Nutrient Management for Dummies. At 1:00 pm, a bus tour will take attendees to the Black River Canal Museum, followed by stops in Lyons Falls, Port Leyden, the ReEnergy Plant in Lyonsdale and Conway Farm. The Hayloft is a beautifully renovated barn, but it is not climate controlled. We suggest dressing in layers according to the day's weather forecast. Northern Border Regional Commission Grant Round Open; Deadline June 19

Established by Congress in 2008, the Northern Border Regional Commission (NBRC) is a working partnership between the federal government and the States of New York, Vermont, New Hampshire, and Maine. The mission of the NBRC is to fund economic development and infrastructure projects throughout designated counties in its four state service area.

Applicants must demonstrate through a sound, comprehensive business plan, based on hard data, proven methodology and reasonable forecasts acceptable to the NBRC, that the applicant is capable of maintaining the project after NBRC funding to assist the sustainability of the project and achievement of the level of service outlined in the project description.

ELIGIBLE PURPOSES

- a. To develop the transportation infrastructure
- b. To develop the basic public infrastructure
- c. To develop the telecommunications infrastructure
- d. To assist its region in obtaining job skills training, skills development, and employment-related education, entrepreneurship, technology, and business development;
- e. To provide assistance to severely economically distressed and underdeveloped areas of its region that lack financial resources for improving basic health care and other public services;
- f. To promote resource conservation, tourism, recreation, and preservation of open space in a manner consistent with economic development goals;
- g. To promote the development of renewable and alternative energy sources.

The NBRC Economic and Infrastructure Development Program is ONLY available to participating member states, local governments (city and county), nonprofit entities, and Native American entities for projects within the NBRC region. In New York, the NRBC region is the counties of Cayuga, Clinton, Essex, Franklin, Fulton, Hamilton, Herkimer, Jefferson, Lewis, Madison, Oneida, Oswego, Seneca, and St. Lawrence. The grant requires a 50/50 match, except for distressed counties. In NY, distressed counties are Cayuga, Clinton, Essex, Franklin, Fulton, Herkimer, Lewis, Madison, Oneida, Oswego, St. Lawrence, and Seneca. The percent of qualified project costs matched by NBRC funds in distressed counties is up to 80%.
