The North Country Regional Economic Development Council (REDC) is holding three community forums designed to get public input in the creation of a five-year economic development plan. (The North Country REDC includes Jefferson and Lewis Counties.) Mohawk Valley REDC to Hold Public Forum

The Mohawk Valley Regional Economic Development Council, which includes Oneida County, will be holding three Community Workshops to share its vision statement for this region, as well as the results of an exercise that identified the regions strengths, weaknesses, opportunities and threats (SWOT). The closest meeting to the Tug Hill Region is on Monday, September 19th from 6:30 pm - 8:30 pm at Mohawk Valley Community College, 1101 Sherman Drive, Utica, NY, Room 225 of the Information Technology Building. Other meeting locations include Amsterdam on September 28th and Cooperstown on September 29th.

Stakeholder group meetings are also being scheduled for September and October in the Mohawk Valley REDC region. Identified groups include: Healthcare, Education, Tourism, Agricultural Forestry and Natural Resources, Housing and Community Development, Manufacturing and Small Businesses. Tax Levy Limit ("Tax Cap") Training Scheduled for September

Tax cap training workshops have been scheduled for Tuesday, September 20th at 7:00 pm at the Boonville Municipal Building (13149 State Route 12) and Wednesday, September 21st at 7:00 pm at the West Monroe Town Hall (46 County Route 11). Two representatives from the Syracuse Regional Office of the State Comptroller (OSC) will present both workshops.

This training program is designed to be timely in assisting calendar year officials (towns, counties, cities, and fire districts) in preparing their annual budgets. However, the material presented will also be useful for non-calendar year government officials (villages, school districts) when it comes time to prepare their annual budgets. All are encouraged to attend. Topics to be covered include an overview of the budgetary responsibilities of municipalities in working within the tax levy limit legislation; resources available to local government leaders to assist with tax levy limit calculations, and suggestions for how to live within the tax levy limit legislation from year to year. There will be ample time for a question and answer period.

Revised Draft Supplemental GEIS On "Hydrofracking" Released

The NYS Department of Environmental Conservation (DEC) released its draft Supplemental Generic Environmental Impact Statement (SGEIS) on September 7, 2011. It is available on their website at http://www.dec.ny.gov/energy/75370.html, as well as several related fact sheets. Note that in additional to environmental impacts, fact sheets/reports on economic and community impacts have also been prepared.

DEC plans to hold four public hearings during the comment period for the SGEIS and regulations in November. The meetings will be held in counties in the Marcellus Shale area, as well as New York City. Dates and locations will be announced shortly.

Public comments will be accepted through the close of business on December 12, 2011 by two methods only:

- Electronic submission using a web-based comment form available on DEC's website (preferred method);
 or
- Paper submission mailed or delivered to: Attn: dSGEIS Comments, New York State Department of Environmental Conservation, 625 Broadway, Albany, NY 12233-6510. Please include the name, address, and affiliation (if any) of the commenter.

Due to the expected volume, comments that are faxed, telephoned, or emailed to the DEC will not be accepted for the official record. This is to ensure that all comments are captured properly and can be included during the review process.

Parish Public Meeting Shows Housing As A Viable Option

Approximately 35 people attended a public meeting on September 8th at the Parish Elementary School to hear the last updates from Fairweather Consulting, the consultant preparing the reuse plan for the Village and Town of Parish. Housing, either for seniors or working families, seems to be the most viable reuse when demographics, housing availability, and community preferences are all taken into consideration. Fairweather Consulting, working together with its partner the DiMarco Group, will soon be assisting the Williamstown and Altmar Elementary Schools as well.

Consolidated Funding Application Released

The new NYS Consolidated Funding Application (CFA), a new process tied to the State Regional Economic Development Councils, was released on September 2, 2011. The CFA will be used as a single source application to apply for \$1 billion in economic development funding. The Governor has directed nine State agencies to make resources available through the CFA process: Empire State Development, NYS Canal Corp., Energy Research and Development Authority, Environmental Facilities Corp., Homes and Community Renewal, Department of Labor, Parks, Recreation and Historic Preservation, Department of State, and Department of Transportation. *Applications will be due October 31, 2011*.

A submitted CFA will be forwarded electronically to the Regional Council that covers the project's geographic area. The Regional Council will then review and rank the applications based on a set of regional endorsement standards and assign the project from 0 to 20 points. Additionally, applications will undergo a technical review by State agencies administering those programs, after which they will notify the Regional Council as to whether or not projects are eligible for funding. State agency scoring criteria will account for 80% of the score, whereas the remaining 20% will be based on the Regional Council review.

Town of Rodman Energy Efficiency Project

The Town of Rodman, with assistance from the Tug Hill Commission, submitted a Renewable Energy Improvement Project grant application to the New York State Energy Research and Development Authority (NYSERDA) back in February of 2010. The application was fully funded for \$174,000, with the Town contributing an additional \$12,000, and is a success story for the Town of Rodman.



The intent of the project was to zero out electrical consumption at the Town garage by installing 144 solar panels and a 3-phase utility interactive inverter. Since the system became operational in early May 2011, there has been a decline in power bills during the months of May, June and July. It will take approximately a year for the Town and National Grid to review the Town's electric usage post construction.

The pictures show the solar panels located on the roof of the garage and the electrical panels which serve to collect the electricity and send it back to National Grid through the net metering process.

Is Dealing With Health Insurance Rates Making You Sick?
