Celebrating 50 Years of Tug Hill Relationships

January kicks off a year of celebration as the Tug Hill Commission reaches 50 years of service in 2023. Celebration activities thus far include a poster contest for high school students, revamped logos, commemorative coffee labels by Tug Hill Artisan Roasters, planning for an extra special annual dinner event in the fall, and an ongoing social media "Throwback Thursday" series posted to Facebook and Instagram.

Over the years, the Tug Hill Commission has worked with many remarkable people, built relationships with dozens of towns and villages, and seen projects of all kinds develop across the region. While many things have changed in 50 years, the Tug Hill remains one of the most remote, natural landscapes in New York State and its communities have retained their unique character and culture. Each week, commission staff plan to take a walk through history to commemorate those important memories and events, and we encourage you to join us on the journey!

Tug Hill Community Projects Funded

Three Tug Hill communities have been awarded funding to date through the state's consolidated funding application. The commission worked directly with the village of Boonville on a joint town and village application to the 2022 - 2023 Environmental Protection Fund Smart Growth Community Planning and Zoning grant. The \$40,500 award will fund the *Town and Village of Boonville Smart Growth Comprehensive Plan Update*. The town and village of Boonville will update their joint comprehensive plan to address smart growth principles and, aim to maintain the area's "small town" character. The rural community includes a small urban area in the village and the areas assets include agriculture, forests, water, and minerals. The goal of the update will be to improve the community's resiliency and economic opportunities while preserving the community's natural assets.

The village of Boonville, through grants writer Lisa Kaiding, was also awarded \$328,125 in Environmental Protection Funds through the NYS Office of Parks, Recreation, and Historic Preservation for the *Erwin Park Renewal* project. The project will revamp the main entrance on NYS Route 12, construct a boardwalk and canoe/kayak launch, create an entrance to the Boonville Black River Feeder Canal, construct an amphitheater with seating built into the surrounding hill, and resurface the tennis court.

The Village of Adams Community Park was also awarded \$322,005 through the NYS Office of Parks, Recreation, and Historic Preservation. This project will rehabilitate the park with recreational features inclusive to all ages and mobility levels, functioning to

serve the community for events, exercise, play, and leisure. The commission has been working with the playground subcommittee of the Adams Revitalization Committee to help define and scope the project and to assist with grant writing, which was completed by Barton and Loguidice.

Lewis County Broadband Expansion Completes First Phase


Residents and businesses in the Port Leyden and Diana areas of Lewis County have a new option for broadband internet access, as Hudson Valley Wireless is now offering internet service in those communities. Lewis County, using funding from the NYS Office of Homes and Community Renewable's Community Development Block Grant program (through the CARES Act), and by installing wireless equipment on existing county-owned towers, has now made internet service available to approximately 599 unserved households. The Development Authority of the North Country provided technical expertise and information to support the effort. Remaining grant funds will cover the cost of installation of customer equipment on a first-come, first-served basis for approximately 200 households that both live within the project area and are income-eligible for the Affordable Connectivity Program (ACP). In addition to receiving free standard installation and free equipment, subscribers that qualify for the ACP will also be eligible for the Microsoft Affordable Computer initiative with laptop or desktop devices starting at \$11.

As part of the ribbon cuttings held this week, Lewis County also celebrated the launch of 27 free public wi-fi hotspots in hamlets and villages through the county. Over the next year, with funding awarded to Lewis County by the Northern Border Regional Commission, Hudson Valley Wireless will expand its service area to include the towns of Harrisburg, Pinckney, Denmark, Lowville, and a portion of Montague. Relative to fiber expansion, through a public/private partnership with Spectrum, Lewis County Legislators also approved the use of ARPA funds to connect approximately 366 potential household in the towns of Croghan, Denmark, Watson, Lowville and Greig to highspeed internet. Furthermore, with funding from NYS's ConnectALL Initiative, the NY Power Authority will be working on a \$10 million pilot program to expand broadband in the town of Diana.

NYSDEC Launches Green Purchasing Communities Program

The New York State Department of Environmental Conservation recently launched a <u>Green Purchasing Communities (GPC)</u> <u>program</u> for local governments and is hosting an informational webinar about it on Tuesday, January 17 at 2:00 p.m. Please register by <u>clicking here</u>. The program provides an easy to administer green procurement program for local governments and provides the community with recognition for implementing it. It's free and all local governments in New York State are eligible to participate.

Local governments that become a GPC commit to following the GreenNY purchasing specifications that NYS government uses. Over 75 different purchasing specifications are included, covering office and building management supplies, electronic equipment and appliances, food service items, and transportation items. There are specifications to follow for a wide variety of items frequently purchased by local governments.

NYS GIS Advisory Group Meeting

Commission staff attended the New York State GIS (Geographic Information System) Advisory Group meeting earlier this week. The meeting brought together people from many different NYS agencies including the NYS Department of Transportation, NYS Thruway Authority, NYS Canal Corporation, NYS Department of Environmental Conservation, and more to talk about how GIS is being utilized and improved upon statewide. The meeting was informative and covered topics such as finding talent pools, hiring strategies, and upgrades to the current NYS Clearinghouse website. The group concluded the meeting by briefly talking about its evolution and what the steps going forward will be.

RACOG Economic Visioning Summit Results

On January 12, a small group made up of Kristen Aucter (Lewis County Chamber of Commerce), Adam Fuller (Fuller Insurance Agency), Mickey Dietrich and Taylor McKinney (Tug Hill Commission), Megan Krowkowski (Lewis County Planning), and Jason Wendt (CREG Systems) met to discuss the results from the 2022 RACOG Economic Visioning Summit SWOT (strengths, weaknesses, opportunities and threats) exercises.

The group focused their efforts on the opportunities portion of SWOT analysis and generated some ideas to share with the RACOG board for feedback. The group will meet again in February to continue going through the SWOT analysis.

Deferiet Solar and Brownfield Opportunity Area Update

At the January 11, 2023 village of Deferiet board meeting, Tom King and Tracy Darougar from the NYS Energy Research and Development Authority updated the board on the status of the potential solar project for the old St. Regis Paper mill site. David Paulsen, Jefferson County attorney, and David Zembiec, Jefferson County Industrial Development Agency, also spoke about the entire mill property and future development potential. Besides solar development, the site will also be considered for light industrial and commercial use. They were followed by Sarah Bullock, Wilna economic development coordinator, who is working on a Brownfield Opportunity Area (BOA) designation with the village of Deferiet for the site. She talked about the status of the BOA, which just recently selected the consultant Elan Planning, Design, and Landscape Architecture, PLLC. to do the study and analysis for the project. Also in attendance was Kylie Peck with the NYS Department of State, who is the regional BOA contact.

As the project progresses, there will be multiple opportunities for public input and community involvement.

Stakeholder Meetings for Sandy Creeks, Black River, and Oneida Lake Watersheds

Three major watersheds in the Tug Hill region are getting much needed watershed management plan updates. All three initiatives are emphasizing public engagement and are hosting stakeholder meetings to gather feedback from interested community members.

For the Sandy Creeks Watershed, the first stakeholder meeting will be held on Tuesday January 17, 2023, 3:00 p.m. to 4:30 p.m. at the Sandy Creek Town Hall, 1992 Harwood Drive, Sandy Creek, NY. Light refreshments will be served, please register here. A virtual option is also available. The 9E Plan will identify water quality concerns, priority areas for water quality sampling, and strategies for addressing water quality concerns. The Sandy Creeks Watershed encompasses all or portions of the Towns of Adams, Ellisburg, Lorraine, Rodman, Worth, Sandy Creek, Boylston, and Richland.

The Oneida Lake Watershed public meeting will be held Tuesday, January 24, 2023, at 7:00 p.m. This plan will describe the community's water quality concerns and provide a strategy to address those concerns. The meeting will be held virtually on Zoom.

The Black River Adaptive Modeling Project, Phase I aims to identify existing water quality data, assess data usability, and identify gaps towards developing an adaptive watershed model for the Black River at the HUC 12 scale.
