

### 4A) The Open Meetings Law: Demystifying the New Videoconference Procedures

Tuscarora

The Open Meetings Law (OML) was first amended to allow public bodies to conduct meetings via videoconference back in 2000. As a result of the COVID pandemic, a more flexible, although temporary, method of conducting meetings was authorized via executive order. New York's experience with this temporary method of conducting meetings led the State to enact new procedures for conducting meetings via videoconference. This session will provide a full explanation of New York's OML, including the procedures for conducting meetings using videoconference technology. The presentation will also highlight recent changes to the OML regarding the public's right to access records that are scheduled to be discussed at meetings, the definition of "public body," and the posting of meeting minutes.

### 4B) Lake Effect and Lightning (LEE) – A "Shocking" SUNY Oswego Project

Meadow

The SUNY Oswego LEE project is funded by the National Science Foundation to study the electrification in lake-effect storms. The two main questions are: 1) How do lake-effect storms become electrified? 2) Do wind turbines initiate lightning during these storms and, if so, under what conditions do these turbines initiate lightning? Sites across Tug Hill hosted weather stations during the winter of 2022-23. Additionally, students launched weather balloons and a Doppler on wheels traversed Tug Hill during lake effect storms.
